Lis updated the Board on the bank loan process. It' still moving forward with the Bank of Colorado. As a condition of the loan we will be moving the HOA's account to the Bank of Colorado. Lis, Jim, and Erika will need to sign on the loan. Lis will notify them when the closing date is set.

Van Horn has modified the drainage plans and we are hoping to sign a contract for excavation soon. The costs are still less than originally thought.

The roofing project is still happening. Looking for completion this fall. There was a slight increase to the original bid as we did not complete the work within 60 days of the bid.

Lis updated us on the special assessment. Lis still believes that the final numbers will come in less than originally thought. Now expecting them to be between \$3500 and \$4000 per unit.

Warren Chalmers asked to assist Joel with the drainage project oversight. The Board felt that was a good idea and support that request.
